TRADE NOTICE No. 05 / 2026

Sub: Introduction of Promotional Concession in Port Dues and Anchorage Fee for Bunkering and Other Maritime Services for Development and Promotion of an Integrated Offshore Maritime Services Hub at Chennai Port Outer Anchorage – Reg.

In order to develop an Integrated Offshore Maritime Services Hub at Chennai Port Outer Anchorage, a promotional scheme is, hereby, launched with effect from 10th August 2026.

Chennai Port Authority (ChPA) hereby introduces a Promotional Concession Scheme providing concession on the applicable Port Dues and Anchorage Fee for vessels calling exclusively at Chennai Port Outer Anchorage, without including inner harbour calls, for any one or more authorized maritime services – bunkering, provisions, stores, spares, crew change, sick crew disembarkation, repairs, underwater operations, surveys and inspections.

The following concession on full non-concessional tariff would be applicable on 'Port Dues' as well as 'Anchorage Fee':

Vessel Category	Promotional Concession
Vessels up to 50,000 GRT	85%
Vessels above 50,000 GRT	90%

Further, '2.1.2 concession/exemption in Port Dues' of the SOR is enhanced as follows:

Description	Existing Concession/ Exemption	Enhanced Promotional Concession/ Exemption
Vessels entering the port only for receiving provisions/stores or fresh water and / or spares.	50%	85% for vessels up to 50,000 GRT; 90% for vessels more than 50,000 GRT
Vessels entering the port only for receiving bunkers and/or crew change or to disembark any sick crew member at anchorage	75%	85% for vessels up to 50,000 GRT; 90% for vessels more than 50,000 GRT

Terms and Conditions

1. The promotional concession shall **apply only on Port Dues and Anchorage Fee** covered under this scheme. All other Port charges shall be payable as per the notified Scale of Rates.
2. The promotional concession shall be applicable **only to service-recipient vessels** calling exclusively at Chennai Port Outer Anchorage, without inner harbour calls.
3. The concession shall be applicable only for vessels calling exclusively for the authorized maritime services listed under this Trade Notice and **shall not apply where cargo operations/ passenger movements are undertaken.**
4. **Interpretations** - Any dispute relating to the interpretation, applicability or implementation of this Trade Notice shall be decided by Chennai Port Authority, whose decision shall be final and binding.

This promotional scheme will be reviewed on 31/03/2027 for efficacy and will accordingly be modified/ extended as required.

This Trade Notice shall come into force with immediate effect from "10/08/2026".
